On March 19, 1998, Mountain Air Express, Inc. d/b/a MAX<sup>1</sup> filed an application under Part 215 of our rules to register the trade names “Air Wisconsin Airlines Corporation” and “United Express” to be used in its operations in connection with its new parent company, Air Wisconsin Airlines Corporation d/b/a United Express,<sup>2</sup> another certificated air carrier.

Part 215 of the Department’s regulations provides that any carrier wishing to use an alternative trade name must first register that name with the Department. The rule further states that the Department may register such name after the carrier gives notification to similarly named carriers of the proposed use of the name. In this case, however, the only similarly named carriers are Mountain Air’s parent company, Air Wisconsin, and those air carriers conducting business pursuant to code share or other operating agreements with United Airlines and, hence, no notification was required.

Since Mountain Air has complied with the requirements of Part 215, we acknowledge the registration of the trade names “Air Wisconsin Airlines Corporation” and “United Express” for use in its operations.
