**TEM ENTERPRISES, INC. d/b/a CASINO EXPRESS AIRLINES
NOTICE OF TRADE NAME REGISTRATION**

On May 25, 1999, TEM Enterprises, Inc. d/b/a Casino Express Airlines (Casino Express), a certificated air carrier,¹ submitted an application under Part 215 of our rules to register the trade name "Tahoe Air."

Part 215 of the Department's regulations provides that any carrier wishing to use alternative trade names must register those names with the Department. The rule further states that the Department may register such trade names after the carrier gives notification to similarly named carriers of the proposed use of the trade name. In this case, there are no similarly named U.S. or foreign carriers.²

Since Casino Express had complied with the requirements of Part 215, on June 1 we acknowledged orally such registration. This notice is to confirm our oral acknowledgment of the registration by TEM Enterprises, Inc. d/b/a Casino Express Airlines to use "Tahoe Air" as a trade name.

¹ Casino Express holds a certificate under section 41102 of Title 49 of the United States Code (Transportation) authorizing it to engage in domestic scheduled air transportation of persons, property, and mail (See Order 91-7-39, served July 3, 1991).

² On December 14, 1998, Tahoe Air Corp. filed an application in Docket OST-98-4912 under section 41102 to provide scheduled air transportation of persons, property, and mail, but subsequently withdrew its application.
