**NOTICE OF REGISTRATION OF TRADE NAMES**

On June 11, 2002, Midwest Express Airlines, Inc., and its wholly owned subsidiary, Astral Aviation, Inc. d/b/a Skyway Airlines, both certificated air carriers, jointly requested that the Department register additional trade names for each carrier. Midwest Express Airlines requested registration of the trade name "Midwest Airlines" for use in certain of its air transportation operations, while Astral Aviation requested registration of the trade name "Midwest Connect."

Part 215 of the Department's regulations provides that any carrier wishing to use an alternative trade name must first register that name with the Department. The rule further states that the Department may register such trade name after the carrier gives notification to similarly named carriers of the proposed use of the trade name. In these two cases, there are no similarly named airlines.

Under these circumstances, we hereby register "Midwest Airlines" as a trade name to be used by Midwest Express Airlines, and "Midwest Connect" as a trade name to be used by Astral Aviation, in the carriers' certificated air carrier operations.
